**A CALL FOR CANDIDATES AND COMMITTEE MEMBERS**

The members of Western Coventry Fire District (WCFD) Board of Directors that form the District's management team today are likeminded in their views of how WCFD should be managed and organized for the present and for the foreseeable future. Because of the support shown by the voters of the District during recent annual meetings, it is evident that these views and resulting actions are generally consistent with the expectations of the vast majority of the District's voters. Those expectations are fire and rescue response for a reasonable tax rate while supporting an effort to avoid being drawn into a significantly more expensive town-wide organization for the same services.

Most importantly, the current WCFD administration believes that major financial decisions must be made with the involvement of and approval by the voters of the District and this practice needs to be maintained by the District's future leadership. Because the current members of the management team cannot be expected to serve indefinitely, it is imperative that other community minded residents that feel strongly about the wellbeing of WCFD become involved.

The election to take place during the District's Annual Meeting on April 1, 2019 will be to fill two of the five Board of Directors positions.

We currently have one Board member who, after serving the District for many years, has indicated he will not be seeking reelection. We also have other Board members who have served for multiple terms but would also like to transition their positions to other, younger, qualified voters with similar views for WCFD when they chose to step down.

The best way to develop an understanding of the workings of the District is to simply attend one or more monthly meetings of the District and to listen and learn what is going on and take the opportunity to participate in the discussions while contributing to the decisions made. Our public board meetings take place on the third Thursday of the month at 7:00 PM at the Summit Station, 1110 Victory Highway. The agendas for these meeting are posted on the RI Secretary of State's web site, <http://www.sos.ri.gov/>, and locally at the Summit Station, Koszela Lumber and Summit General Store at least 48 hours in advance of these meetings.

In addition to the Board of Directors' positions, we have a need for assistance at the committee level. As examples, the Standard Administrative Procedure Committee (responsible for the creation and updating procedures for the control of the District in compliance with the District's Charter and By-Laws and the Charter and By-Laws Committee (addressing and recommending to the voters By-Laws that continuously need updating to keep pace with our ever changing legal and demographic environment). Involvement with these committees is yet another very important and excellent way to compliment your service to our community.

The success of this appeal for more concerned residents of the District to become involved is critical to the continuation of an efficient, cost effective and independent fire district. Please consider getting involved.
